



**INSTRUCTIONS
LOT LINE ADJUSTMENT
and / or
LOT SPLIT APPLICATION**

TO MAKE AN APPLICATION FOR LOT LINE ADJUSTMENT OR LOT SPLIT THE PROPERTY OWNER MUST PRESENT, AT LEAST TWO WEEKS PRIOR TO THE PLANNING COMMISSION MEETING, THE FOLLOWING TO THE TOWN CLERK AT THE GOLDSBY TOWN HALL, GOLDSBY, OKLAHOMA:

- 1. A completed application form**
- 2. Attach an original accurate survey or drawing of the lots involved, prepared and sealed by a land surveyor registered in the State of Oklahoma, drawn to scale, indicating the following:**

Attachment #1- Lot lines as platted, dimensioned by lengths and bearings or angles, showing:

- a. Adjacent street rights-of-way with names and widths**
- b. Building lines**
- c. All easements, and**
- d. Existing buildings, if any**

Attachment #2- Lot lines as proposed, dimensioned by lengths and bearings or angles, showing:

- a. Adjacent street rights-of-way with names and widths**
- b. Building lines**
- c. All easements, and**
- d. Existing and proposed buildings, if any**

Attachment #3- A revised legal description for each new lot.

- 3. An application fee of \$5.00 (non-refundable) for each lot or portion involved.**

The Planning Commission may approve or disapprove a request.

If approved by the Planning Commission and signed by the Town Clerk-Treasurer, the applicant will then file the approved Lot Split or Lot Line Adjustment with the McClain County Clerk.

(After recording the documents with McClain County return a copy to the Goldsby Town Hall)

A completed, approved and filed Lot Split/Lot Line Adjustment with the appropriate zoning classification is necessary before an application for a building permit can be approved.
